Why leave a gift in your will to the Centre for Sustainable Healthcare?

How to remember us in your will

Types of gifts in wills

There are several ways to leave a gift in your will. You could leave:

- a share of your estate once other gifts and payments have been made
- a fixed sum, the value of which may decrease over time as the cost of living increases.

You could also name a particular item in your will: for example, a piece of jewellery or other belonging.

At the present time (September 2022), most charitable gifts in wills are tax free, and you may be able to reduce the amount of inheritance tax payable. Your professional adviser will be able to help you and provide the most up to date advice.

How will my gift be used?

If you choose to kindly leave a gift in your will to the Centre for Sustainable Healthcare, you can be sure that it will be received gratefully and spent wisely to make a real difference. We are extremely grateful for all gifts in wills; those without restrictions are particularly vital as they enable us to act where most urgently needed.

Can you provide legal advice about the wording of my will?

We are sorry but our charity is unable to offer any legal or financial advice and we strongly recommend you obtain your own independent professional advice. We hope you can appreciate that your will must be exactly that – yours – and not influenced in any way.

Your will should accurately reflect exactly what you want to happen. A will is a legal document and any conditions within need to be met before the legacy would be released.

Just let your legal adviser know exactly what you want, and they will ensure that your wishes are clearly expressed.

I don't have much. Is there a minimum I can leave?
